The level of domestic abuse on the Island has been of concern to the Crime & Disorder Reduction Partnership (CDRP) for some time. During the quarter ending 31/12/09 there were 222 domestic crime incidents and 180 arrests were made (see Local Indicator N1 32a of papers D and D1). The Hampton Trust has been tasked with researching the domestic abuse situation on the Island and Kim Brown, Chief Executive of the Trust, will brief the Scrutiny Panel on this.
