36. [Call In of Delegated Decision 08/11 – Objections to the Isle of Wight Council \(Various Streets, Newport\)\(Traffic Regulation\) Order No 1 2010](#)

The lead member for the call in, Councillor Jones-Evans, outlined the reasons for calling in the delegated decision and the desired outcomes as stated in the relevant notice. This centred on the views of the local member who had considered that the proposed parking restrictions were too severe.

The Committee was advised that the Chief Financial Officer had indicated that the cost of implementing the order was within the approved budget. The Monitoring Officer had indicated that the decision was within the policy framework and was a lawful.

The Cabinet Member for the Environment, Transport and Corporate Services, Councillor Giles, outlined the background to the delegated decision that he had taken. He responded to the specific issues raised and advised on the discussions and correspondence involving the local member on the content of the draft traffic regulation order. In clarifying some of the

concerns that had been expressed about the roads involved it was noted that one related to Nelson Road rather than Winston Road.

The consultation process for dealing with representations to traffic orders and the involvement of local members was discussed. It was noted that only where written objections had been submitted to advertised proposals did the cabinet member get involved in the final decision.

Councillor Hollis spoke on the item and made reference to taking a proportional approach to parking restrictions and the costs involved in implementation.

In summing up the lead member for the call in sought the support of the committee in requesting that the cabinet member consider amending the proposed traffic regulation order for Newport.

RESOLVED :

THAT the cabinet member be recommended to make the following amendments to the draft Isle of Wight Council (Various Streets, Newport) (Traffic Regulation) Order No 1 2010 :-

- a) Nelson Road and Linden Road – no further parking restrictions be implemented unless these are at the request of the local member;
- b) Watergate Road – the proposed no waiting at any time restriction be amended to no waiting 8am to 6pm Monday to Friday;
- c) St John's Road – the proposed no waiting at any time restriction be amended to no waiting 8am to 6pm Monday to Saturday.
