Council resolves, in the light of increasing public concern, to recommend to the Cabinet that they reverse the 2011 Budget decision and subsequent delegated decision (15/11) to transfer the Isle of Wight Fire Control service to Surrey Fire and Rescue Service, with the loss of savings for this year of £125k to be drawn from General Reserves. Further it recommends to Cabinet that any future alternative provision of this service must be Island based and preferably based on a shared emergency services approach – (Paper G)
