"In view of the widespread public concern, and as the Isle of Wight Council has not received guidance from the Department for



Children and Family Services on any issue of concern to be addressed by the Primary Capital Programme, by 31 January, Council resolves to abandon the current informal consultation on educational reorganisation. Council also instructs the Cabinet Member for Children and Young People to secure from officers a plan and consultation proposals for managing surplus school places that does not result in mass school closures and damage to the local communities."
