John Prescott True To His Word

You will recall from the Spring 2005 edition of **PENSIONS UPDATE** that certain changes were made to the Local Government Pension Scheme (LGPS). The main changes, effective from 1 April 2005, were as follows:

- 1 Increasing the earliest retirement age from 50 to 55.
- 2 Raising Normal Retirement Date for all Scheme members to age 65. By removing the "85 year rule, any benefits paid before age 65 will be reduced to take account of early payment.

As a result of pressure from the Unions, the Deputy Prime Minister, John Prescott, promised to revoke these changes at the "earliest Parliamentary opportunity". On Tuesday 13 July, the Government announced that the changes have now been revoked and so all the changes set out in the previous edition no longer apply.

Annual Benefit Statements

All employees who were Scheme members as at 31 March 2004 would have received an Annual Benefit Statement detailing their current benefit position (at 31 March 2004) as well as their projected benefits at age 65 and information relating to death benefits. This year's statement, based on membership and pay to 31 March 2005, should be sent out a little earlier, hopefully October/November.

Civil Partnerships

With effect from 5 December 2005, the Civil Partnership Act 2004 will allow same-sex partners to register a civil partnership. From that date, same-sex couples wishing to form a civil partnership will be able to notify the Registration Service. The earliest date a registration ceremony can take place will be 21 December 2005.

The proposed amendments to the Local Government Pension Scheme will provide survivor benefits for civil partners in the event of the death of an active, deferred or pensioner member. Only membership after 5 April 1988 will count in calculating any such benefits.
