







Isle of Wight Local Data (for Local Area Agreement Indicator NI70a)

The Isle of Wight Local Area Agreement set a target to reduce the number of alcohol-specific hospital admissions, in response to the IW's high comparative rate as shown above. However the IW data for this target shown below is not directly comparable with the data counted for the NWPHO indicator shown above, since NWPHO counts each person admitted only once, regardless of the number of times they are admitted, whereas for the NI70a indicator each person is counted each time they are admitted.
