COMMENTS ON PLANNING APPLICATIONS

- 1. P/01649/12 LDC/14543/F Lawful Development Certificate for continued use of caravan as residential unit at Jolliffes Farm, Nettlecombe Lane, Whitwell: **NO OBJECTION; recommend approval**
- P/01359/12 TCP/14737/G Alterations and conversion of barn to form residential unit to include single storey side extension (revised plan corrected red line) (readvertised application) at Bevois Farm, Laceys Lane, Niton: Previous comments carried forward from 22nd October 2012: OBJECTION; recommend refusal on the following grounds:
 - The situation regarding the bat roost needs clarification; the Parish Council requests that an ecological survey be carried out on the barn to establish if the bats have gone and to check that the conditions of the original planning application have been satisfied;
 - There is a lack of utilities and parking, since the plans are for an individual dwelling.

The Parish Council requests a site visit from the Isle of Wight Council Planning Committee.
