The Clerk read the list of correspondence received. In relation the One Million Blooms grant, it was agreed that the balance of funding should be held for the After School Club to use on projects involving the children.

ANY OTHER URGENT BUSINESS (Not requiring a resolution) 41/09-10

- (a) Cllr. Court said the Landlord of the Four Seasons should be congratulated on his initiative in restoring the drinking trough.
- (b) Cllr Davison reported vandalism to cars left overnight in St Martins Rd car park and wondered if CCTV would assist. It was unlikely that this could be afforded however.
- (c) Cllr Rickards said the promised bollards to protect the daffodil verge had never appeared. Clerk to see is J. Wood was still involved.
- (d) Cllr Clayton said brambles at the bottom of Stenbury View were blocking the pavement. He wondered if anything could be done about the trailer parked in the lay-by near the Donkey Sanctuary – Mr Dea wa already taking action on this and was interested to learn the land was owned by Southern Water. He reported dirty bus shelters; Mr Dea said IW Council had a programme to attend to all shelters over a period of time. He thought the IW Council hosted website was too difficult to find and wondered if ParishCouncil.com would be a better option – this was charged for whereas IWC provided hosting free.

- (e) Cllr Langdon said the bollards south of the old railway bridge had been vandalised Mr Dea was already dealing with this. She reported that an action group had been formed to oppose SW Housing's wheel-clamping proposals for their land in St Martins Rd.
- (f) Cllr Gallop said he had been pleased to see Cllr Downer and the PCSO 'walking the beat' together.
- (g) Mr Dea reported that £1200 had been made available for the police allotment project and recently retired Sgt Clarkson would be responsible for managing this. The Restorative Justice Service had made an excellent job of clearing the site and Jane Swan and Steve Gibbins should be congratulated. The key had been given to PC Payne To be passed on to Mr Clarkson.
