ANY OTHER URGENT BUSINESS (Not requiring a resolution)

- (a) Cllr Cole the road name sign marking the change from Station Rd to Castle Rd was missing, resulting in confusion amongst delivery drivers. He drew attention to continued thoughtless parking outside Gresham House.
- (b) Cllr Underwood said there had been several minor accidents in St Johns Rd where opposing traffic tried to squeeze past the parked cars, including one involving a bus. Cllr Gallop reminded the Council that it had opposed parking restrictions here.
- (c) Cllr Clayton raised a query regarding signage at disabled bays.
- (d) The Chairman asked to be supplied with an allotment key to pass on to the Football Club.

Cllr Downer reported a new Concealed Entrance sign was to be erected and a new street light in Stenbury View. He had reminded Highways of the need for one in Clarence Rd. The IW Council grass cutting contract was to be retendered. He was following up on improvements to drainage at Redhill Lane and near the Donkey Sanctuary.

**Public questions** Mr Prescott advised that the outstanding planning applications for wind turbines at Ventnor Golf Club and Span Farm were due to be considered by the Planning Cttee of IW Council on 6 October. The Clerk reminded Members that they had submitted objections to both these applications in 2009. They could attend the Cttee meeting and speak if invited. Members rehearsed their views on renewable energy and felt that wind turbines should generally be placed in off-shore locations.
