(c) Cllr Bennett asked if salt bins were going to be provided before the winter. Cllr Downer had carried out some preliminary investigations and Cllr Davison agreed to help him bring a costed proposal to the next meeting.

(d) Cllr Gallop said the southbound bus stop in St Johns Rd was being swamped by brambles. Cllr Downer said he had already raised this with IWC Highways.
