#### 49/09-0 CORRESPONDENCE

# 50/09-10 ANY OTHER URGENT BUSINESS (Not requiring a resolution)

- (a) Cllr. Rickards said the recent police radar trap in the village had been in the wrong place at the wrong time and took four PCs to put into effect. This led to a more general debate on speeding and it was agreed to approach Highways for extension of the 30 mph limit northward towards Whitely Bank, and to seek a limit in Redhill Lane.
- (b) Cllr Davison said that better signs with a Wroxall logo were needed to replace the Welcome to Wroxall signs. The Clerk would obtain a quotation.
- (c) Cllr Underwood wondered if resurfacing of Rew Lane could be extended up to the car park. This was a private road maintained by Mr Corey.
- (d) Cllr Langdon said the parking on the west side of Clarence Rd was too long without a gap for vehicles to pull in. The Chairman said that the double yellow line restrictions had been reviewed recently. She was also concerned that the PCSO had 'disappeared' when the post was needed to monitor youth congregating in the evenings. The Chairman would speak to Neil Payne regarding this.
- (e) Cllr Downer said a residents' meeting had complained about speeding i in Avenue Rd. The ownership of the Leylandi at Green Bank had been confirmed and it was hoped the dead ones would be removed. He was planning to initiate a Parish Surgery shortly.
