# Local Transport Plan (LTP)

The Transport Act requires local transport authorities to produce a Local Transport Plan setting out the authority's transport strategy and delivery programme.



The Isle of Wight's second LTP was adopted in 2006 and will run until 2011 and includes:

- 20 year transport vision.
- Five year strategy.
- Implementation plan.

As part of the review process the council has produced a progress report detailing spend, targets and delivery during the first two LTP2 years.

## Targets

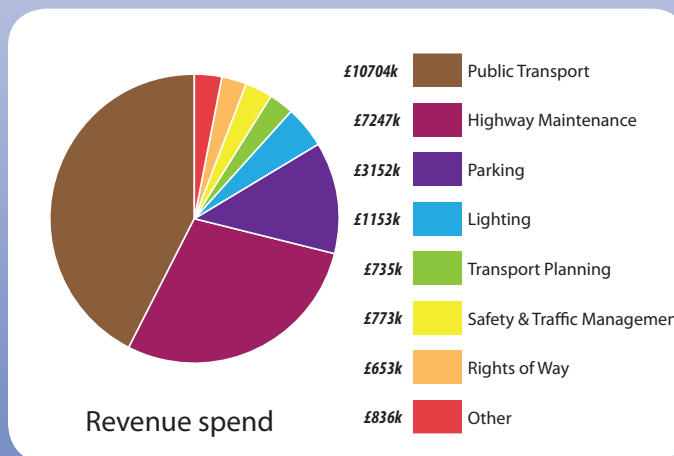
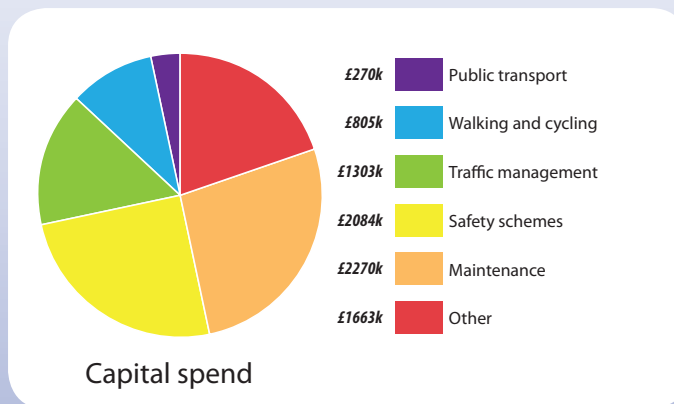
As at 31 March 2008:

- 15 targets on track.
- Five targets not on track.
- One target unable to assess.



## Spend

Between April 2006 and March 2008 the council spent £33.6 million on transport schemes and support.



# Delivery

The council, in partnership with others, has made significant transport improvements over the last two years including:

### Increasing accessibility

- Improved access to Newport.
- Delivered Carisbooke Accessibility Action Plan.
- Continued support of 'student rider' public transport scheme – over 2.7m journeys undertaken.

### Promoting economic prosperity

- Established Island freight forum.
- Gained planning consent for Ryde interchange.

### Road safety

- Developed acclaimed 'driver awareness' training course.
- Introduced 'pre-driver safety education' for all sixteen year olds.
- Installed 150 speed reactive signs.
- Trained over 6,700 children in cycle safety.

### Improving air quality and environment

- Installed 75 new pedestrian crossings.
- New trial of bio-diesel for council fleet.

### Tackling congestion

- Approved a further 32 school travel plans.
- Supported Community Rail Partnership.
- Introduced bus timetable SMS text scheme.

### Ensuring effective management

- Completed over 100 road and footway maintenance schemes.
- Selected as 'pathfinder' authority for highway Private Finance Initiative.
