## Final Consultation Statement Community Engagement Conformity Check

#### Introduction

The Community Engagement Conformity Check Consultation Statement is one of the background document's that details who was consulted in each parish and how the issues raised informed the production of the final document. The consultation statement has been updated to include the consultation undertaken by the Council toward the formal adoption of the community documents as Supplementary Planning Documents (SPDs). The council considers that the final consultation statement provides sufficient detail to satisfy Part 5, Regulation 12 of the Town and Country Planning (Local Planning) Regulations 2012.

### Consultation undertaken by the Isle of Wight Council

The community documents and accompanying background documents were made available on the council's website and at Planning Reception, Seaclose Offices, Customer Services, County Hall and Ventnor, Ryde and Freshwater Libraries as these are the nearest core libraries to each administrative area. The consultation period lasted for six weeks, running from 27 July 2012 to 10 September 2012. A copy of the notice advertising the consultation period can be found at the end of the document.

During the consultation period, the council received no comments on the documents. The council notified the parish and town councils that no comments were raised and unless there were any suggested changes that the respective parish and town councils would like to make, the council would proceed with the delegated decision and move towards formal adoption. The parish and town councils had no suggested changes to make and welcomed the progress being made towards the formal adoption of each community plan.

# Chale Village Design Statement, Nettlestone and Seaview Parish Plan and Yarmouth and Thorley Community Plan Supplementary Planning Documents Consultation

At the request of the local communities of Chale, Nettlestone and Seaview and Yarmouth and Thorley, the Isle of Wight Council is consulting on the content of community documents with a view to adopting them as Supplementary Planning Documents (SPDs) within the Island Plan Local Development Framework.
