Action 3.1 specifies the need to identify sites for a residential nursing home. Although the provision of this type of accommodation will have no impact on age and disability as identified above, this aspect could contribute to the opportunities for equality and for this reason this has been noted above.

Action 3.3 specifies the need to identify sites for affordable housing for the community. Although the document will have no impact on the protected characteristics as identified above, this aspect could contribute to the opportunities for equality and for this reason this has been noted above.

Action 4.3 addresses the need to increase and maintain better quality footpaths. Although the improvements for pedestrian safety and accessibility will have no impact on age and disability as identified above, this aspect could contribute to the opportunities for equality and for this reason this has been noted above.

Nettlestone and Seaview Parish Plan has been through local public consultation and has been adopted by the Parish Council.

The aim and benefits of the Nettlestone and Seaview Parish Plan is to give people in Nettlestone and Seaview the opportunity to provide their views on the future of the area to ensure that the needs and aspirations of different groups of people have been taken into consideration when developing the plan. The community as well as local businesses, landowners, societies, clubs and historic building occupiers were consulted by questionnaire and through public meetings and community events. The questionnaires were designed for the local community and additional consultation was undertaken with pupils from the local primary school. The results were analysed and reproduced in the document.

Public meetings were organised to help formulate the parish plan and a questionnaire compiled and delivered to 1700 households throughout the parish. During the production of the plan various stakeholders attended monthly meetings including officers from the Isle of Wight Council.

As well as providing evidence on how local people have been consulted, the document has also been

the subject of a conformity check with the policies of the Island Plan Core Strategy and the National Planning Policy Framework. This conformity check has concluded that the content of the guidance is in general conformity with the Island Plan Core Strategy.

The plan will also be subject to further consultation as part of its formal adoption as a SPD. This statutory process requires a six-week period of public consultation. The Council will make reference to the fact that the plan has had a detailed local consultation and will involve both the Parish Council and Isle of Wight Council elected Councillor for the area. It will be important for the Council to consider all comments that come forward from the consultation and discuss any changes that may be needed with the Parish Council.

The six week period of public consultation took place between the 27 July and the 10 September and during this time the Council received no comments on the plan. Therefore no further Equality Impact Assessment was required.

### Demographic Data

The table below indicates ward data taken from the 2010 Office for National Statistics (ONS) mid year estimate and other sources including Working Age claimants at November 2011 from the Department for Works and Pensions (DWP). This data shows a population of some 2,836 for the ward of Nettlestone and Seaview and of this 46% are of pensionable age (60 years plus).

When considering the numbers of those living in the ward of Nettlestone and Seaview with some form of disability who may benefit from improved footpath links and accessibility, a range of information is available. This includes the number of people claiming incapacity benefit and severe disability allowance. The data identifies 125 people claiming benefits in the Nettlestone and Seaview area and of these 36% are claiming incapacity benefit or severe disability allowance.

### **Analysis and assessment**

Given that the aim of the Nettlestone and Seaview Parish Plan is to ensure that the needs and aspirations of different groups of people have been taken into consideration when developing the plan, the following provides an assessment of the consultation feedback.

The consultation was undertaken by Nettlestone and Seaview Parish Council. The following identifies the number of people who responded to the consultation by completing questionnaires designed specifically for people in the local community. Comments received helped to shape the content of the document.

Of the 1700 questionnaires delivered to households in the locality 853 were returned, a response rate of 51%.

From the assessment of the Nettlestone and Seaview Plan, it was identified that there are aspects that could contribute to the opportunities for equality of the protected characteristics identified in the initial screening process. This is in respect of the following:

- Improving footpath linkages could help the elderly and those with mobility issues access a range of local services and facilities.
- The provision of affordable housing and a residential nursing home for local people in

Nettlestone and Seaview. Identify sites that could accommodate low cost housing.

• Retaining access to open space in the village for local people.

### Recommendations

To approve the adoption of the Nettlestone and Seaview Parish Plan as a Supplementary Planning Document.

To undertake discussions with Development Control colleagues over the treatment of an individual's protected characteristics in determining planning applications in Nettlestone and Seaview as and when required.
