Evidence Considered During Screening

In January 2012, the Isle of Wight Council consulted with Cowes Town Council and the two local councillors (Paul Fuller and George Brown) and support was received in writing via email. It is also minuted in the Cowes Town Council meeting held on 2nd February 2012.

Further to the support being received, the scheme was then included in the Integrated Transport project, which was approved on 3rd April 2012 under delegated decision powers, by the Cabinet Member for Highways, Transport and Waste as part of the Highways and Transport Capital Programme 2012 – 2013.

The scheme has been designed in line with the Department for Transport's Inclusive Mobility guidance and Guidance on the use of Tactile Paving Surfaces, which are intended to help service providers fulfil their statutory obligations under the Equality Act 2010.

Further to the support being received, the scheme was then included in the Integrated Transport project, which was approved on 3rd April 2012 under delegated decision powers, by the Cabinet Member for Highways, Transport and Waste as part of the Highways and Transport Capital Programme 2012 – 2013.

The installation of the zebra crossing will not only improve road safety and accessibility for school children but for all pedestrians, especially the mobility impaired, elderly and young families.
