The Aims, Objectives and Expected Outcomes:

Different groups of people within the local community have different needs and aspirations as to how they want their community to develop in the future. This would include what services, facilities and local infrastructure are important to them. Given this, the aim and benefits of the Yarmouth and Thorley Community Plan is to give people in Yarmouth and Thorley the opportunity to provide their views on the future of the area over the next ten to fifteen years from 2009.

The objective of the plan is to describe the community, its local distinctiveness and its place within the Island context. Provide information on how people were consulted and summaries these findings.

The outcome is a rolling plan of delivery in the action plans.

The final stage of the process is to submit the plan to the Isle of Wight Council so that it can be considered for formal adoption as a Supplementary Planning Document (SPD). Whilst the document can formally be considered in the planning process once adopted as a material consideration, any proposal that requires planning permission within the Yarmouth and Thorley area will still be judged on its own planning merits.

The following aspects have been taken from the Yarmouth and Thorley Community Plan Action Plans:

Action B2 addresses the need for an open space within the parish which is accessible to all groups. Although the document will have no impact on the protected characteristics as identified above, this aspect could contribute to the opportunities for equality and for this reason this has been noted above.

Action B10 addresses the work to improve road safety by the installation of traffic control measures to reduce speed. Although the improvement of road safety will have no impact on age and disability as identified above, this aspect could contribute to the opportunities for equality and for this reason this has been noted above.

Action B11 specifies the need to provide footpaths in the centre of Thorley and between Thorley and Yarmouth for pedestrians and those pushing prams. Although the improvements for pedestrian safety and accessibility will have no impact on age, disability and maternity as identified above, this aspect could contribute to the opportunities for equality and for this reason this has been noted above.

Action C2 addresses the provision for a community bus for the elderly which would help this group access local shops and services. Although the provision for a community bus will have no impact on the protected characteristic age, this aspect could contribute to the opportunities for equality and for this reason this has been noted above.

Action D1 specifies the investigation for the need for affordable housing for the community. Although the document will have no impact on the protected characteristics as identified above, this aspect could contribute to the opportunities for equality and for this reason this has been noted above.

Evidence Considered During Screening

Yarmouth and Thorley Community Plan has been through local public consultation and adopted by the Parish Council.

The aim and benefits of the Yarmouth and Thorley Community Plan is to give people in Yarmouth and Thorley the opportunity to provide their views on the future of the area to ensure that the needs and aspirations of different groups of people have been taken into consideration when developing the plan.

The community as well as local businesses were consulted with flyers, questionnaires and through public meetings. The questionnaires were designed for adults and young people and the results were analysed and produced in the document.

Yarmouth Town Council resolved on 6 November 2007 to hold public meetings to consult on the preparation of a parish plan. These took place in Yarmouth and Thorley with a total of 93 attending, representing some 22 local organisations as well as individual residents, and a total of 27 volunteered to help with the project. Between 27 October and 14 November 2008 Steering Committee members and other volunteers delivered 945 flyers to households in Yarmouth, Thorley, and peripheral areas of Bouldnor and Halletts Shute/West Hill. From 1 April 2009 962 adult questionnaires were delivered to households in the locality and also a youth questionnaire for 10-17 year olds was devised by a working group and distributed to schools and youth centres.

As well as providing evidence on how local people have been consulted, the document has also been the subject of a conformity check with the policies of the Island Plan Core Strategy and the National Planning Policy Framework. This conformity check has concluded that the content of the guidance is in general conformity with the Island Plan Core Strategy.

The plan will also be subject to further consultation as part of its formal adoption as a SPD. This statutory process requires a six-week period of public consultation. The Council will make reference to the fact that the plan has had a detailed local consultation and will involve both the Parish Council and Isle of Wight Council elected Councillor for the area. It will be important for the Council to consider all comments that come forward from the consultation and discuss any changes that may be needed with the Parish Council.

The six week period of public consultation took place between the 27 July and the 10 September and during this time the Council received no comments on the plan. Therefore no further Equality Impact Assessment was required.

This data shows a population of some 3,334 for the ward of West Wight (including Yarmouth and Thorley) and of this 39% are of pensionable age (60 years plus).

When considering the numbers of those living in the ward of Yarmouth and Shalfleet with some form of disability who may benefit from improved footpath links and accessibility, a range of information is available. This includes the number of people claiming incapacity benefit and severe disability allowance. The data identifies140 people claiming benefits in the Yarmouth and Shalfleet area and of these 50% are claiming incapacity benefit or severe disability allowance.

Analysis and assessment

Given that the aim of the Yarmouth and Thorley Community Plan is to ensure that the needs and aspirations of different groups of people have been taken into consideration when developing the plan, the following provides an assessment of the consultation feedback.

The consultation was undertaken by Yarmouth Town Council between the 27 October and 14 November 2008 and from the 1 April 2009. The following identifies the number of people who responded to the consultation from individual flyers delivered to households in the locality or by questionnaires designed specifically for adults and young people in the community. Comments received helped to shape the content of the document.

Flyer Consultation

Of the 945 flyers delivered to households in Yarmouth, Thorley, and the peripheral areas, 301 flyers

were returned, a 32% response rate. There were over 2,500 comments received which have been documented.

Adult Consultation by Questionnaire

Of the 962 adult questionnaires delivered to households in the locality 405 were returned, a response rate of 42%.

Consultation with Young People

Of the questionnaire for 10-17 year olds delivered to schools and youth centres, 55 questionnaires were returned and of those 40% were from Yarmouth and Thorley residents.

From the assessment of the Yarmouth and Thorley Community Plan, it was identified that there are aspects that could contribute to the opportunities for equality of the protected characteristics identified in the initial screening process. This is in respect of the following:

- Improving footpath linkages between Thorley and Yarmouth could help the elderly and those with mobility issues access a range of local services and facilities in Yarmouth.
- Improve road safety and traffic control measures in Yarmouth by introducing a 20mph zone for the Conservation Area of Yarmouth. This could help the elderly and those with mobility issues access a range of local services and facilities.
- Investigate the provision of a community bus for the elderly. This could help the elderly and those with mobility issues access a range of local services and facilities.
- Investigate affordable housing need for local people in Yarmouth and Thorley.
- Provide an open space and young children's play area in Thorley.

Recommendations

To approve the adoption of the Yarmouth and Thorley Community Plan as a Supplementary Planning Document.

To undertake discussions with Development Control colleagues over the treatment of an individual's protected characteristics in determining planning applications in Yarmouth and Thorley as and when required.
